## VI. TERMS AND CONDITIONS

- a. Applications are made to the governing authority of Victory Christian School which reserves the right to accept or reject any application.
- b. Victory Christian School admits students of any race, color, or national and ethnic origin to all rights, privileges, programs and activities generally accorded or made available to students of the school. Victory Christian School does not discriminate on the basis of race, color, or national and ethnic origin in administration of its educational policies.
- c. Students and parents are required to read and abide by the Student/Parent Handbook. School policies may be changed by the administration when deemed necessary. Applicants agree to abide by all school policies, rules and regulations, including provisions for dress codes and discipline. Victory Christian School has full discretion in the discipline of students while at the school. All forms (including the financial agreement and medical forms) must be received by the school office before enrollment is official.
- d. Applicants agree that their students will receive instruction in the Christian Faith and understand that the school will endeavor to be guided by a Christian worldview in all of its programs and activities.
- e. VCS is a ministry of Victory Christian Center. Therefore, Victory Christian School provides priority enrollment for children of Victory Christian Center members, children of Victory Christian School graduates, and children with enrolled siblings. All enrollment criteria must be met regardless of priority status.
- f. The school has policies designed to meet a reasonable standard of care for students who become ill or have an emergency situation at school. Parents are required to sign a medical release form each year allowing emergency medical care to be obtained in the case parents cannot be reached. Parents understand the school is not an insurer of student health. Parents are fully responsible for any costs as a result of necessary medical attention while at school (this includes PE, Athletics, and all other extra-curricular activities).
- g. The school's Schedule of Charges provides information about financial terms and obligations. It is updated annually.
